
1. Objective of the MoU

- a. To establish a mutually beneficial relationship built on academic cooperation.
- b. The PARTIES, having discussed the fields of common research interests and allied activities between the two institutions have decided to enter into a long term collaboration in the areas of Teaching pedagogy, Faculty and students training programmes, Research projects, Research publications and Interactions for quality enhancement.
- c. To conduct study tour, a mutually agreed in writing between both institution's prior commencement of this activity.

2. Goals and Forms of Collaboration

The signing Institutions agree to provide opportunity, as appropriate for the following activities towards the completion of the objectives of this MoU-

- a. Joint collaboration of students and/or researchers with the objective of offering courses and realizing research, internship in areas mutually agreed upon by both institutes through prior invitation through and in accordance with the procedures and expectations established by each Institute and specific department.









- b. Exchange of books publications, cultural programme, academic projects, course information seminars, lecture demonstration for workshop, conferences and other data and information of common interest.
- c. Lectures of faculty members of specific department on special topics.
- d. Organize Joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate institute entity.
- e. Provide research guidance and extend facilities to conduct research leading to research degrees.

3. Implementation of the Memorandum of Understanding

The objectives of the MoU will be implemented and regulated in the following manner.

Students exchange

Student and research scholars may visit the corresponding departments of these institutes after finalizing a mutually acceptable schedule.

4. Duration and Residence of MoU-


- a. The agreement will take effect from the date of its signing changes to this agreement shall be made by mutual consent between both institutions. In case of disagreement, the institute willing to depart from the agreement shall, wherever possible, give two months notice of its intention to do so. The Agreement shall be reviewed after a period of three years.
- b. There is no financial and legal commitment on the part of both the parties to take up any program mentioned in this MoU. If there is any financial consideration, it will be dealt separately as per proposer's parent institutional administrative and financial approvals or as per mutual agreement.


